Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were five insurance applications reviewed in August 2024. All five applications were approved by the IALC.

The registration of approved insurance entities occurs after the IALC application process has concluded. Therefore, the IALC approval and the registration approval may be rendered in different periods.
