## Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were 17 insurance applications reviewed in November 2024, all of which were new applications. Of the 17 applications, 14 were approved by the IALC and three were deferred.

The registration of approved insurance entities occurs after the IALC application process has concluded. Therefore, the IALC approval and the registration approval may be rendered in different periods.
